**Reservation**

Reservation shall be applicable for SC/ST/OBC (NCL) as per the Apprentices Act 1961 and Apprenticeship Rule 1992 amended from time to time.

**Age criteria:**

Minimum 18 years and maximum 27 years as on the closing date of the application form

**Stipend:**

1. The apprentices are eligible for monthly stipend as per Apprentices Act, during their period of engagement subject to satisfactory performance and attendance.
2. Poor performance or unauthorized absence may result in termination from the apprenticeship program.
3. The apprentices are not eligible for any TA-DA/Boarding or Lodging expenses incurred during the period of apprenticeship. The Government Engineering College, Dahod will not provide any financial assistance towards transportation.

**Selection of Candidates:**

Shortlisting/Screening/Selection will be based on the merit according to eligibility criteria and prescribed qualification applicable to the respective trade and the number of vacancies notified in the detailed advertisement. Reservation shall be applicable for SC/ST/OBC (NCL) as per the Apprentices Act 1961 and Apprenticeship Rule 1992 amended from time to time.

A merit list will be prepared based on the candidates reported for document verification process and found suitable as per the eligibility criteria. Shortlisted candidates will be communicated through the registered email. TA/DA will NOT be paid for appearing for the document verification process.


The candidate shall be engaged in merit order on accepting tri-partite apprenticeship contract on the NATS/NAPS website and submission of a medical certificate in the prescribed format and police verification by the candidates.

**General Conditions:**


1. Candidates are advised to carefully read the full advertisement for details of eligibility criteria and selection modalities before submission of application.
2. The interested candidate must have a valid mobile number & E-Mail ID before applying for apprenticeship.
3. During the period of apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended in 1973 and till date) and the policies/rules of the organization.
4. Reservation for SC/ST, OBC and EWS as applicable in Government of India (GoI) will be followed.



5. Government Engineering College, Dahod shall have no obligation to offer regular employment to Apprentices during and/or after successful completion of the apprenticeship period, candidates will be relieved on completion of tenure.
6. The decision of organization will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the management based on suitability of candidates and no claim will be entertained, if some of these seats are not filled due to unsuitability/insufficient number of candidates.
7. Government Engineering College, Dahod does not take any responsibility to reply to the candidates for non-selection/non-issuance of call letter.
8. Candidates applying for more than one discipline will not be considered and their application will be rejected.
9. No Application Fee is being charged.
10. The candidates should NOT have undergone Apprenticeship earlier or pursuing Apprenticeship Training as per the Apprentices Act, 1961, as amended from time to time.
11. Candidates, who had training or job experience for a period of one year or more after the attainment of prescribed qualifications, shall NOT be eligible for being engaged as Apprentice.
12. The applicant for the position should NOT have completed 5 years after passing of the qualifying examination as on the closing date of the applications. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College / Institute from where the candidate pursued his/her course at the time of verification of documents.
13. Applications/Registration which are incomplete or not fulfilling the eligibility criteria shall not be considered "Eligible" and treated as "Rejected".
14. At any stage of the selection process, if it is found that the candidate has furnished false or incorrect information, then the candidature/engagement of the candidate is liable to be cancelled.
15. Training for apprentices will be held at Government Engineering College, Dahod, Gujarat only.
