**MEMORANDUM OF UNDERSTANDING**

In order to promote co-operation between Department of Humanities and Applied Science, Government Engineering College, Dahod, hereinafter referred to as "GEC-Dahod" and the Mathematics Department, Navjivan Science College, Dahod, hereinafter referred to as "NSCD, Dahod", the two institutions agree as follows:

1. The two institutions will encourage direct contact and co-operation between their faculty and administrative staff, departments and research activities.
2. The Parties agree to explore and facilitate collaboration in the following areas:
  - Exchange of faculty members and research scholars.
  - Sharing of academic materials, publications, and research outputs.
  - Joint research activities, including co-supervision of Ph.D. scholars.
  - Organization of joint conferences, workshops, seminars, and symposia.
  - Any other mutually beneficial academic or research initiatives.
3. It is agreed that the terms and conditions of any agreed programme and activity contemplated in this MoU shall be the subject matter of separate written agreements to be negotiated and agreed upon by both Parties and/or any third parties, wherever applicable, PROVIDED ALWAYS, the decision whether to initiate and/or implement any programme or activity shall be at each party's sole discretion.
4. This memorandum is not intended to create binding or legal obligations on either party. It merely expresses the intentions and understanding of the Parties, which will form the basis of any legally binding agreement to be drafted and executed in the future.
5. Both parties understand and agree that this memorandum creates no financial obligations on either party, and all financial arrangements will have to be negotiated and will depend on the availability of funds.
6. Both Parties agree to maintain the confidentiality of information exchanged under this MoU, unless such information is already in the public domain or required to be disclosed by law or under a separate agreement.
7. This MoU shall have an initial term of five years ending on 12.12.2030 and will be renewed for another period of five years term after reviewing the activities performed under this MoU

unless written notice by one party to another party for not renewing the MoU is given not later than one (1) month before the expiry of the current term. This MoU may be terminated at any time by mutual written consent or by three (3) months' notice in writing by either party.

8. Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing, in English and delivered personally or sent by registered or certified post via airmail or by courier or email (which shall be acknowledged by the other Party) to the Parties at the addresses stated below:


